- **04.** Scholarships for Meritorious SVV students: We offer specialized scholarships to top performers in the Class X Board exam. The student who attains the first position in Class X will be awarded a comprehensive education sponsorship, encompassing a full 100% scholarship for both classes XI and XII. The next four high-achievers will qualify for a 50% reduction in tuition fees, and the subsequent five outstanding students will receive a 25% scholarship. - **05.** Application for L.C.: Kindly note that if any parent wishes to withdraw their child from the school, whether due to a job transfer or any other reason, a written application must be personally delivered to the administrative office by **February 15, 2025**.
