04. Scholarships for Meritorious SVV students: - We offer specialized scholarships to top performers in the Class X Board exam. The student who attains the first position in Class X will be awarded a comprehensive education sponsorship, encompassing a full 100% scholarship for both classes XI and XII. The next four high-achievers will qualify for a 50% reduction in tuition fees, and the subsequent five outstanding students will receive a 25% scholarship. This scholarship program spans a two-year duration, supporting education in both Class XI and Class XII.

05. Application for L.C.: - Kindly note that if any parent wishes to withdraw their child from the school, whether due to a job transfer or any other reason, a written application must be personally delivered to the administrative office on or before by **February 15, 2026**. In such cases, no fees for the upcoming session will be levied. Failure to submit a withdrawal request by this date will be interpreted as an intention to continue enrolment for the next session, and fees will be applied as per the established norms. It is advisable to make a timely decision in this matter to facilitate the admission process for other students currently on the waiting list. We extend our appreciation to all parents for your continuous encouragement and support of various school programs and activities throughout the year.
